



## **Do You Need Spay/Neuter Assistance for Your Dog?**

PAL would be happy to help with spay/neuter assistance for your dog. PAL is working with Willamette Valley Animal Hospital in Keizer, OR. If you would like to utilize our services, please send a money order payable to PAL in the following amount:

1. With proof of government assistance, there is a co-pay of **\$25 per dog (\$50 per dog if your dog is 100 lbs. or more).**

**Government assistance include the following. If you qualify, please send a copy of one of the following along with your co-payment:**

- Oregon Health Plan Enrollment
- Medicaid Enrollment
- Supplemental Nutrition Assistance Program (SNAP) or Oregon Trail Card
- Housing Assistance, such as Section 8
- Woman Infant Child (WIC) Special Supplemental Nutrition Program Enrollment
- Social Security Benefits
- Proof of Unemployment Benefits or Status

2. All others individuals have a co-pay of **\$80 per dog (\$100 per dog if your dog is 100 lbs or more).**

- **Name**

- **Dog's Name, Age, Breed, Sex & Weight**
- **How did you acquire your dog? Breeder? Rescue or Shelter? Friend of Family? FREE from Craigslist or online?**
- **How did you hear about PAL?**
- **Is your dog currently licensed? If no, has your dog ever been licensed?**

When we receive your money order and information above, we will send Willamette Valley Animal Hospital the okay for the spay/neuter and also send you a confirmation email. You will then be able to make your appointment directly with WVAH. The spay/neuter includes a rabies shot (if needed) so your dog will be ready to license. **Licensing your dog is a requirement for using the PAL Spay/Neuter Assistance Program.**

- If you are a resident of Marion County, you must purchase the license on the day of spay/neuter at Willamette Valley Animal Hospital (\$17 per year for spayed/neutered dog; \$5 for senior citizens 65 years or older) or show proof of current license at the time of the spay/neuter.
- If you live in another county, you must license your dog within 30 days of the spay/neuter and send proof of licensing to PAL. If you do not send the proof of licensing within 30 days, your spay/neuter information will be sent to your county's dog control.

**PAL does not cover any other shots or services.** Any services in addition to the spay/neuter and rabies shot will be your responsibility and will need to be paid at the time of service. If you do decide to use our services, we would appreciate it if you sent us a photo of your dog so that we may celebrate him/her on our website and Facebook.
